Definitions and Interpretation

 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;

- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

Scope of this Privacy Policy

- 3. This Privacy Policy applies only to the actions of WFS Flooring & Tiles Ltd. and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, WFS Flooring & Tiles Ltd. is the "data controller". This means that WFS Flooring & Tiles Ltd. determines the purposes for which, and the manner in which, your Data is processed.

Data That is Given to Us by You

- 7. WFS Flooring & Tiles Ltd. will collect your Data in a number of ways, for example:

Data That is Collected Automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:

Your Rights
